**Foliar Application - Greens, tees, fairways and sports fields:**

Apply 2 - 5kg / Ha a month  
(Apply with **Fulmax<sup>®</sup>** at 3 - 5L / Ha)

If the pH of the water is alkaline, add **Fulmax<sup>®</sup>** first until the pH comes down to 6 - 6.5, then add **Endurance<sup>®</sup> 18% Fe**.
